**Explanation of Responses:**

- Each restricted stock unit represents a contingent right to receive one share of the Company's common stock as of the vesting date. Accordingly, these restricted stock units were settled in shares of common stock.
- The reporting person serves as co-trustee of the MJCF Hall Family Trust, of which the reporting person and his wife are trustees and beneficiaries.
- The options are fully vested.
- No transaction is being reported at this time. This line is only reporting holdings as of the date hereof.
- The options are currently vested with respect to 35,000 shares. The remaining options vest on March 14, 2023.
- The options are currently vested with respect to 11,250 shares. The remaining options vest in two installments as follow: 6,250 shares on March 14, 2023 and 7,500 shares on March 14, 2024.
- The options are currently vested with respect to 5,000 shares. The remaining options vest in three installments as follows: 4,000 shares on March 13, 2023; 5,000 shares on March 13, 2024 and 6,000 shares on March 13, 2025.
- The options are currently vested with respect to 2,000 shares. The remaining options vest in four installments as follows: 3,000 shares on March 12, 2023; 4,000 shares on March 12, 2024; 5,000 shares on March 12, 2025 and 6,000 shares on March 12, 2026.
- The options vest in five installments as follows: 3,000 shares on March 14, 2023; 4,500 shares on March 14, 2024; 6,000 shares on March 14, 2025; 7,500 shares on March 14, 2026 and 9,000 shares on March 14, 2027.
- The restricted stock units were granted under the Monster Beverage Corporation 2011 Omnibus Incentive Plan. Each restricted stock unit represents a contingent right to receive one share of the Company's common stock as of the vesting date.
- The remaining restricted stock units vest in two installments as follows: 2,125 units on March 14, 2023 and 2,550 shares on March 14, 2024.

- The remaining restricted stock units vest in three installments as follows: 1,400 units on March 13, 2023; 1,750 units on March 13, 2024 and 2,100 units on March 13, 2025.
